INTRODUCTION

This Cookie Policy applies to all users of this website. The information presented below is intended to inform the users of this website about the placement, use and management of cookies in the context of browsing this website.

We use the term "cookies" to refer to cookies and similar technologies through which information can be collected automatically.

Cookies are used to provide users of this website with a better browsing experience and services adapted to the needs and interests of each individual user, namely for:

- improving the use of this website, including by identifying any errors that occur while visiting/using it by users;
- providing anonymous statistics on how this website is used to Sport Time ("**Sport Time**", "**we**"), as the owner of this website;
- anticipation of possible services/goods that will be provided/made available to users through this website in the future, depending on the services/products accessed.

Cookies provide Sport Time with valuable feedback on how this website is used, so that measures can be taken to make this website more efficient and accessible to users.

Thus, the use of cookies allows the memorization of certain settings/preferences established by the users of this website, such as:

- the language in which a web page is viewed;
- rates are expressed.

1. WHAT ARE COOKIES?

An "Internet Cookie" (term also known as "browser cookie" or "HTTP cookie" or "cookie") is a small file, consisting of letters and numbers, which will be stored on the computer, mobile terminal or other equipment of a user through which the Internet is accessed.

Cookies are installed through the request issued by a web server to a browser (eg: Internet Explorer, Firefox, Chrome). Once installed, cookies have a fixed lifetime, remaining "passive", in the sense that they do not contain software, viruses or spyware and will not access information on the hard drive of the user on whose equipment they were installed.

A cookie consists of two parts:

- the name and
- the content or value of the cookie.

From a technical point of view, only the web server that sent the cookie can access it again when a user returns to the web page associated with that web server.

There are the following categories of cookies:

- **Session Cookies** – A "session cookie" is a cookie that is automatically deleted when the user closes their browser.
- **Persistent Cookies** – A "persistent cookie" is a cookie that remains stored on the user's terminal until it reaches a certain expiration date (which may be minutes, days, or years in the future).

2. WHAT IS THE LIFETIME OF COOKIES?

Cookies are managed by web servers. The lifetime of a cookie can vary significantly, depending on the purpose for which it is placed. Some cookies are used exclusively for a single session (i.e. session cookies) and are no longer retained from the moment the user leaves the website. Some cookies are retained and reused each time the user returns to that website (i.e. persistent cookies). However, cookies can be deleted by the user at any time through the browser settings.

3. WHAT ARE THIRD PARTY COOKIES?

In addition to the cookies set by Sport Time, certain sections of content on the website may be provided by third parties, i.e. not by Sport Time, in which case these cookies are called "third party cookies".

Third party cookie providers must also comply with the data protection rules and privacy policy available on this website.

These cookies may come from the following third parties: Google Analytics, Facebook, Youtube.

4. HOW TO USE COOKIES THROUGH THIS WEB PAGE:

By using/visiting the website, cookies may be placed for the following purposes:

- a. Cookies **strictly necessary** for the optimal functioning of the website;
- b. Cookies for **statistical analysis** of users and the way they interact with the website;
- c. **Performance** cookies to improve user experience;
- d. Cookies for **advertising and marketing**.

a. **Strictly necessary cookies:**

These essential cookies allow you to navigate our website and use its features. These cookies do not collect information about you that could be used for advertising or to record your internet activity.

6. WHAT TYPE OF INFORMATION IS STORED AND ACCESSED THROUGH COOKIES?

Cookies store information in a small text file that allows the browser to be recognized. This website recognizes the browser until the cookies expire or are deleted.

7. CUSTOMIZING YOUR BROWSER SETTINGS REGARDING COOKIES

If the use of cookies is not bothersome and the computer or technical equipment used to browse this website is used only by you, long expiration periods can be set for storing the browsing history.

If the computer or technical equipment used to browse this website is used by several people, the setting to delete individual browsing data every time the browser is closed can be considered.

8. HOW CAN COOKIES BE DISABLED?

Disabling and refusing to receive cookies can make this website difficult to visit, leading to limitations in its usability.

Users can configure their browser to reject cookies or to accept cookies from a specific web page.

All modern browsers offer the possibility to change cookie settings. These settings can usually be accessed in the "options" section or in the "preferences" menu of your browser.
